

JAS Fee Schedule

1. Audit Fees

The total fees for each type of certification activity are:

Qualification Audits	\$30360
Surveillance Audit	\$13700
Scope Extension Audit	\$6280
Partial Audit	\$ By quote

Audits conducted without notice shall be charged as per the table below

Audit Description	Fee
Audit conducted without notice that covers the full requirements of, and replaces the annual surveillance audit.	\$13700
Audit conducted without notice that covers the full requirements of JAS Audit – including testing, and does not replace annual surveillance audit.	\$6280
Audit conducted without notice that covers the full requirements of JAS Audit – excluding testing, and does not replace annual surveillance audit.	\$1280 plus expenses

The qualification audits fee includes an initial document review, assessor's time and testing fees for 3 onsite audits and an annual certification fee. If the qualification audit requires more than 3 onsite audits, these will be charged as Additional Charges as detailed below.

The surveillance audit fee includes assessor's time, testing fees and an annual certification fee. This fee may be discounted by the EWPA if product testing is not required.

The scope extension audit fee includes assessor's time and testing fees.

These fees are subject to GST.

2. Audit Fee Loading

The audit fees detailed above will be adjusted based on the level of risk associated with the location of each site. The fee will be calculated as follows:

$$\text{Total Fee} = \text{Base Fee} \times (1 + k + m)$$

The k factor accounts for the DFAT advisory level of the country:

DFAT Advisory Level	DFAT Loading (k)
1	0
2	0.5
3	1.0
4	Certification is not available

The m factor accounts for the Corruption Perception Index (CPI) as published by Transparency International:

$$m = \frac{225 - 3 \times CPI}{100}$$

Where CPI \geq 75, m=0. Where CPI < 30, the ability to provide certification will be determined on a case-by-case basis and shall be at the discretion of the CEO.

These factors shall be reassessed on an annual basis prior to surveillance audits and fees will be adjusted accordingly. If the DFAT warning level for a country reaches Level 4 or the CPI drops below 30, certification may be suspended or terminated.

3. Expenses

The following expenses shall be charged for all certification activities outside of Australia.

Flights	At cost. Business class fares apply for flights over 6 hours.

Meals	At cost
Country specific security arrangements	At Cost

4. End Product Grading Audits

The fee for the EWPA to perform the visual inspection and sample section components of an End Product Grading Audit is \$1280 plus expenses.

The fee for End Product Grading testing is \$10000. This fee is based on 10 samples and may be discounted for a lower number of samples.
