

JAS Fee Schedule

1. Audit Fees

The total fees, excluding expenses, for each type of certification activity are:

Qualification Audits	\$44,080
1 st shipment Audit	\$6,500
Surveillance Audit	\$14,600
Scope Extension Audit	\$11,500
Partial Audit	\$ By quote

These fees are in \$AUD and subject to GST.

Audit Description	Inclusions
Qualification Audits	Initial document review. 3 onsite audits. Testing fees for 3 onsite audits (one end product grading audit per onsite audit). Annual certification fee. Assessors time. If the qualification audit requires more than 3 onsite audits, these will be charged as Additional Charges as detailed below.
1 st shipment Audit	Onsite audit. Testing fees for one end product grading audit. Assessors time. This fee will be waived if conducted as part of the first 6 monthly audit.
Surveillance Audit	Onsite audit. Testing fees for one end product grading audit. Annual certification fee. Assessors time. This fee may be discounted by the EWPA if product testing is not required.
Scope Extension Audits	Testing fee for one end product grading audit. Assessors time.

Audits conducted without notice shall be charged as per the table below:

Audit Description	Fee
Audit conducted without notice that covers the full requirements of, and replaces, the annual surveillance audit.	\$14,600
Audit conducted without notice that covers the full requirements of JAS Audit – including testing, and does not replace annual surveillance audit.	\$6,500
Audit conducted without notice that covers the full requirements of JAS Audit – excluding testing, and does not replace annual surveillance audit.	\$1,500 plus expenses

2. Travel Risk Assessment Fee

These fees are not applicable in the country of operation of the certification body (Australia).

These fees are not applicable to New Zealand due to international relationship between Australia and New Zealand and routine travel between both countries.

Travel Risk Assessment shall be completed, and fees shall be assessed in accordance with the following:

- Risk assessments completed using Smart Traveller.
- Requirement for visas to be considered.
- 15% increase for countries with Advisory level outlining caution.
- 30% increase for countries with Advisory level outlining significant issues for travellers.
- % increase is calculated using and applied to surveillance base fee (surveillance fee minus the cost for testing).

3. Expenses

The following expenses shall be charged for all certification activities outside of Australia:

Flights	At cost. Business class fares apply for flights over 6 hrs.
Travel Time	\$140 per hour

Country specific security arrangements	At Cost

4. End Product Grading Audits

The fee for the EWPA to perform the visual inspection and sample section components of an End Product Grading Audit is \$1500 plus expenses.

The fee for End Product Grading testing is determined by quote based on product type and sample size.
