JIS Fee Schedule

1. Audit Fees

The total fees for each type of certification activity are:

Initial Application	\$14080
Surveillance Audit	\$9600

These fees cover the annual certification fee and assessors time onsite. The initial application fee also includes an initial document review and report.

These fees exclude all testing (detailed below) and are subject to GST.

2. Travel Risk Assessment Fee

These fees are not applicable in the country of operation of the certification body (Australia).

These fees are not applicable to New Zealand due to international relationship between Australia and New Zealand and routine travel between both countries.

Travel Risk Assessment shall be completed, and fees shall be assessed in accordance with the following:

- Risk assessments completed using Smart Traveller.
- Requirement for visas to be considered.
- 15% increase for countries with Advisory level outlining caution.
- 30% increase for countries with Advisory level outlining significant issues for travellers.
- % increase is calculated using and applied to annual certification fee.

3. Expenses

The following expenses shall be charged for all certification activities outside of Australia.

Flights	At cost. Business class fares apply for flights over 6 hours.
Travel Time	\$140 per hour
Car Hire	At cost
Accommodation	At cost
Meals	At cost
Country specific security arrangements	At cost

*EWPA may where possible group audits for clients in similar geographical locations together. When multiple client audits are conducted during one trip expenses will be shared between the clients accordingly. For example: Conducting an audit for 2 clients in New Zealand during the same trip will result in each client paying only half of the cost of international flights.

4. Testing Fees

4.1 <u>Qualification Testing – New Products</u>

Prior to certification of new products, initial type testing must be performed. The fees for this testing are:

Non-Overlaid Products\$2650 + sample prep fee of \$150 per hourOverlaid Products\$5000 + Cost recovery for Change in Colour Resistance Testing +sample prep fee of \$150 per hour

Qualification testing of new products includes testing of 10 panels for all applicable Items for Type Inspection listed in the applicable JIS standard except for formaldehyde. The fee also includes testing of 3 panels (6 sets of specimens) for formaldehyde emissions.

Overlaid products will be tested for Change in Colour Resistance by a subcontract laboratory. The cost of this testing will be recharged to the client at cost.

4.2 <u>Qualification Testing – Product Changes</u>

When a client makes changes to a product that is already certified testing must be performed. The testing required is dependent on the change being made and the following guidelines shall be applied:

- Changes to raw board / substrate: Raw board testing including formaldehyde Testing fee: \$1500 + sample prep fee of \$150 per hour
- Overlay paper changes: Overlay testing only
 Testing fee: \$1300 + Cost recovery for Change in Colour Resistance Testing + sample prep fee of \$150 per hour

Qualification testing for product changes includes testing of 5 panels for all applicable Items for Type Inspection listed in the applicable JIS standard except for formaldehyde. For raw board / substrate changes, the fee also includes testing of 3 panels (6 sets of specimens) for formaldehyde emissions.

Overlaid products will be tested for Change in Colour Resistance by a subcontract laboratory. The cost of this testing will be recharged to the client at cost.

EWPA may increase the number of samples or properties required for testing for the qualification of product changes if it is deemed necessary to ensure the product conforms to the applicable JIS standard.

4.3 <u>Surveillance Testing</u>

Where surveillance testing is required, the fee for this testing is \$1400 per month + sample prep fee of \$150 per hour.

Certification testing includes testing of 5 panels for all applicable Items for Delivery Inspection listed in the applicable JIS standard except for formaldehyde. The fee also includes testing of 1 panel (2 sets of specimens) for formaldehyde emissions.

4.4 <u>Audit Testing</u>

During surveillance audits, samples will be selected for independent testing. The fee for this testing will be:

Product Testing	\$1500
Emission Testing	\$360 per sample
Sample prep fee	\$150 per hour

Product testing includes testing of 5 panels for all properties listed under Surveillance Testing. Emission testing includes testing of formaldehyde emissions of 3 panels (6 sets of specimens).

EWPA may increase the number of samples required for testing if it is deemed necessary to ensure the product conforms to the applicable JIS standard.

The following additional fees will apply when applicable:
